LISTING

As of 30 April, 2016, 30 securities of 18 issuers were listed and admitted to trading at NASDAQ OMX Armenia: 12 stocks of 11 issuers and 18 bonds of 8 issuers.

No new securities were listed and/or admitted to trading, as well as no securities were delisted this month.

EXCHANGE TRADING

All financial figures are in Armenian Drams (AMD) unless otherwise noted. Exchange rates established by the Central Bank of Armenia as of April 30, 2016 were as follows: $USD\ 1 = 478.61$, $EUR\ 1 = AMD\ 544.75$.

Equities Market


In April, 10 trades with total value of AMD 56,148,732 were concluded in the equities market: 186,289 stocks of 1 issuer were traded. All the trades were concluded through continuous two-way auction.

As compared to the previous month (March, 2016) the number of trades, the number of securities traded and the total value traded increased 1.4, 2.9 and 3.74 times, repectevily.

Number of Trades and Value Traded in Equities at NASDAQ OMX Armenia, 2016 (monthly)





Corporate Bonds

During April, 2016, 38 trades in corporate bonds were concluded for a total value of AMD 720,064,208, of which AMD 720,064,208 equivalent to USD 1,245,831 were concluded in USD denominated bonds. Overall 2,975 bonds of 3 issuers were traded. This month the trades were concluded through both continuous two-way auction and manual trading mechanizm.


Compared to the same period of the previous year (April, 2015) the number of trades and the total value traded increased 7.60 and 14.8 times, accordingly, while the number of bonds traded decreased 1.56 times. As compared to the previous month the number of trades and the number of bonds traded decreased by 22.45% and 87.63%, respectively, while the total value traded increased by 33.73%.



Government Bonds

In April, 2016, 37 trades in Government bonds were concluded with total value traded (by purchase price) of AMD 1,466,675,591. As compared to the previous month, the number of trades and the value traded increased by 15.6% and by 56.6%, respectively.

As compared to the same period of the previous year (April, 2015), the number of trades and the value traded (by purchase price) decreased by 7.5% and 24.5%, respectively.

Ministry of Finance of RA granted ARARATBANK, ArdshinInvestBank, ArmSwissBank, Converse Bank, HSBC Bank Armenia, VTB BANK (Armenia) and AMERIABANK the status of government debt management agent to provide simultaneous bid and ask quotes of the following benchmark government bonds AMGN36294183, AMGN60294190, AMGN60294208, AMGB1029A232, AMGB20172323 and AMGB1029A257 in the trading system. To ensure implementation of this process NASDAQ OMX Armenia in its turn granted the above mentioned agents the status of market maker.


As of April 30, 2016, 2,231 companies had their shareholder registries kept with the CDA.


Securities placements, registered at the Depository in 2016
